Facts:

On Aug. 6, 2005, plaintiff Maria Lemus, 49, reportedly slipped and fell in a puddle of water on the floor of a Costco in Victorville.

Lemus sued Costco Wholesale Corporation, alleging that its negligent maintenance caused the accident.

Lemus claimed that Costco's floor was unreasonably dangerous because it was not slip-resistant when wet.

Costco claimed that its floor was absolutely safe under the expected conditions, and that it exercised greater than ordinary care so the floor stayed safe.

Injury:

Lemus was diagnosed with a torn medial meniscus in her left knee. She also alleged a head injury and pain in her shoulder, elbow and lower and middle back. She claimed headaches, too.

Lemus underwent physical therapy and used painkillers, a knee brace and a walker during her recovery. Lemus claimed that she would later need three knee replacement surgeries.

Lemus submitted \$5,340.80 in past medical bills. Her future medical costs were estimated at \$270,000.

She claimed \$27,259 in lost wages. Her future loss of earning capacity was estimated at \$64,279. (Lemus had worked packing products for about a month prior to the accident.)

Lemus asked the jury for between \$850,000 and \$950,000 in total.

Result:

The jury found in favor of the defense.
